### **Consultant Summary**

Kate Pearce presented a summary of goals pertaining to arts and cultural resources of the plans reviewed in the region.

Goals common to all 5 counties include:

- Historic Preservation
- Cultural Preservation
- Preserve Natural Resources

Goals common to 4 of the 5 counties include:

- Establish & promote events and festivals
- Promote local artisans
- Link cultural & historic sites
- Increase cultural tourism
- Preserve natural environment
- Promote & preserve national forests and parks
- Heritage museums
- Rural mountain history
- Preserve & restore historic sites
- Promote small town culture and economy
- Promote farmer's market
- Promote local food economy



- Promote agri-tourism
- Promote active local farming

Goals common to 3 of the 5 counties include:

- Promote musical heritage
- Create greenways to promote cultural tourism
- Open space preservation
- Engage and educate the local community
- Preserve historic corridors

### **GroWNC Process and Public Meetings**

Kate gave an overview of the process for GroWNC and timeline of events, including the Reality Check (public meetings) which will take place in May. The purpose of the Reality Check is to introduce the project to the public and invite feedback on the goals and objectives from each workgroup.
